





## Welcome to the 2017-2018 Silver State Volleyball Club Season

Player registration with NCVA via USA Volleyball at a cost of \$70. All new & returning players must complete this process to be able to practice.


### Step 1 Register with NCVA – USA VOLLEYBALL

- Go to [www.ncva.com](http://www.ncva.com)
- Scroll to the bottom of the home page and click on 
- Read through instructions on the NCVA Registration page

#### If you have played club volleyball in ANY USA Volleyball region:

- Click on 
- **Login** with username and password from previous seasons or click **Forgot Username/Password**
- Follow instructions to complete registration and pay the \$70 fee
- On the 2<sup>nd</sup> page of registration, please select **Silver State VBC** from the dropdown menu at the upper right of the page
- In the Membership Option section, please select **NCVA Junior Membership**

#### If you have NOT previously registered with a USA Volleyball region:

- Click on 
- **Follow** the registration process and pay the \$70 fee
- On the 2<sup>nd</sup> page of registration, please select **Silver State VBC** from the dropdown menu at the upper right of the page
- In the Membership Option section, please select **NCVA Junior Membership**

### Step 2 Print out the USAV Membership card, USAV Medical Release form, and Letter of Commitment form

- Print out:
  - (1) USA Volleyball Membership Card

- (2) USA Volleyball Medical Release Form
- (3) Letter of Commitment from
- **Sign** both the Medical Release and the Letter of Commitment forms (both the players AND parent need to sign both forms)

## Step 3 Turn in signed paperwork in: Reno to the black box hanging from the cubbies next to the front counter, in Carson to the “Forms and Checks” box on counter.

- Turn in to SSVV:
  - (1) **Copy of** NCVA/USA Volleyball Membership card which can be found at the end of the registration process
    - o This card needs to show Silver State VBC as the club, otherwise you will need to log back in and select Silver State VBC.
  - (2) **Signed** Medical Release Form
  - (3) **Signed** Letter of Commitment
  - (4) Payment – players that pay in full with cash or checks receive a 10% discount, in full with credit card receive a 5% discount. All other players will need to make a \$500 payment for Premier League and \$1,000 payment for Power League to reserve a spot on the team. If you are planning on making payments, a Promissory Note must be on file.
