SILVER STATE VOLLEYBALL CLUB Parent & Player Rules

Commitment

- A player is considered committed once they have submitted all necessary paperwork and for **July Tryout**, made their <u>nonrefundable</u> roster payment 48 hours after the conclusion of tryouts.
- Failure to commit means that your roster spot may be given to another player.

Team Formation

• Players and/or staff maybe added or removed from a team at any point during the season. **Behavior**

• All members of SSVC (coaches, players and families) will be respectful of the officials, players, opponents and other volleyball personnel.

Playing Time

• Playing time is at the discretion of the coach and varies according to the player position, skill level and situation.

Attendance

- If a player misses two (2) practices without notice
 - Parent will receive a communication from management asking for an explanation.
 - Player will not play for two matches at the next tournament.
- If a player continues to miss practice without notice
 - Player will be removed from the team.
 - Family will receive refund as outlined below in Financial Obligation section.

Financial Obligation

- Families are expected to pay all required costs for participating in club volleyball. Failure to do so may lead to removal from the team and impact future participation.
- Families that need alternative payment options need to make this clear prior to commitment.
- Should a player not finish the season, a prorated refund will be given. The refund will subtract the expenses including: coach salary, gym fees, tournament costs and uniforms. The parents will receive a letter detailing refund.

Travel

- Parents are responsible for all transportation to and from tournaments.
- Parents agree to stay at the team hotel when required.

Problem Resolution Process

- If a parent has a concern, they need to contact management by emailing <u>info@silverstatevolleyball.com</u>. A meeting will be set up if necessary.
- Parents are not to approach coaches to discuss issues they have with the players, team, club, ext.

Disciplinary Action Process

- Failure to comply with these standards will lead to disciplinary action by the club as described below
 - First violation will result in an email warning.
 - Second violation will result in a meeting with club administration.
 - Third violation will result in player being removed from the club.
